Please note, only those vehicles pre-authorized as part of your confirmation process will be allowed on the parade route. Any vehicles without proper authorization will be denied access to the staging area and the parade route - no exceptions.

Mandatory Rules & Regulations - by submitting application you certify your group will comply.

Our goal is to create a safe and fun parade for everyone who participates, entrants and spectators alike. We've developed the following rules and regulations in pursuit of that goal, and your compliance is mandatory. Please review and share these rules and regulations with everyone in your group prior to parade day. As the primary representative of your group, you certify all members will comply and be bound by these rules and regulations. Any instructions given by authorized parade representatives must be followed. Failure to comply by any member of your group may result in immediate removal of your entire group from the parade route.

- * All entries (including people, carts, vehicles, etc.) are required to be decorated reflecting the celebration of Halloween, Dia de Los Muertos or the Fall Season, no exceptions. If any entry requires support vehicles that are not directly participating in the entry's performance, those support vehicles cannot travel along the parade route with the entry. Arrangements should be made for those vehicles to meet their entry at the disbanding area.
- No entry may exceed 13' in height.
- Ours is a family friendly, non-denominational, non-partisan parade. No profanity, no political or religious opinion or advertisement, no other objectionable material or signage may be displayed or disbursed on or near the parade route.
- ❖ No smoking or alcohol consumption by parade participants on or near the parade route.
- ❖ All drivers of floats or vehicles shall possess a valid driver's license.
- No disbursement of any items such as candy, treats, leaflets, papers, silly string, etc., is allowed while on the parade route.
- No discharging of firearms, similar types of noisemakers, or fireworks of any kind allowed.
- ❖ Steady distance between parade groups must be maintained. All participants are required to close any lengthy gaps between groups. All groups must be mindful of the distance between themselves and the groups in front and in back of them, and maintain proper distance accordingly.
- ❖ Entrants may perform along the parade route, as long as their **performance does not stop the forward movement** of the parade. Any dancing, singing or other performance must be within the context of the **moving** parade. We have experienced long gaps which take away from a "good show" and **it is imperative your group continues moving forward even during performance time**.
- Liability for injury or damages on or around any group or entry will be the sole responsibility of the entrant.
- Animals in the parade require pooper scoopers be provided by the entrant to follow their animals and collect waste immediately.
- ❖ Your group's position in the parade is at the sole discretion of the Anaheim Halloween Parade Committee.

IN CONSIDERATION of being granted a position as an entrant and/or permission to participate in the ANAHEIM HALLOWEEN PARADE 2022, (the "Parade"), or on behalf of a minor child, the undersigned agrees and states as follows:

The undersigned is aware of and understands the inherent risks, hazards and dangers associated with parade participation and the undersigned nevertheless elects, voluntarily, to enter and/or participate in the Parade on the terms, conditions and covenants set forth herein. In this regard, the undersigned, for himself/herself/itself and for his/her/its heirs, successors, assignees, personal representatives and next of kin, hereby releases, waives, discharges, covenants not to sue and agrees to hold harmless the Anaheim Fall Festival/Anaheim Halloween Parade; all Parade volunteers, employees and/or representatives; the City of Anaheim; the County of Orange; the providers of official parade vehicles; and each of them, as well as their officers, directors, agents, volunteers and employees; from all liability for any and all causes and claims of every type and nature whatsoever, including but not limited to property damage, injury to person and/or death, or otherwise, without limitation, arising out of or alleged to be arising out of the conduct of the Parade, the pre-Parade formation, staging, placement, organizational meetings, post-Parade ceremonies and any other sanctioned Parade event.

The undersigned hereby promises that the state of his or her physical health (if this release is on behalf of an individual), or the physical health of the persons representing the undersigned in this Parade (if this release is on behalf of an organization) will, on the day of the Parade, be sufficiently sound to permit such person(s) to safely participate. If such person(s) will be handling any animal, motorized vehicle, apparatus, device, or other thing in the Parade, he/she/they is/are possessed of sufficient experience in doing so such that the life, limb or property of self and others will not be exposed to unreasonable risk of harm.
